Welcome to TeachersPayTeachers.com.

The following describes the terms on which TEACHERSPAYTEACHERS.COM (referred to herein as "TEACHERSPAYTEACHERS," "we," or "us") offer you access to our services. Your permission to use the TEACHERSPAYTEACHERS Service, and the licenses granted herein, are expressly conditioned upon your acceptance of these Terms of Service, and the following additional terms and conditions and policies, which are hereby incorporated by reference (collectively, the "Agreement"):

1. Description of Service.

TEACHERSPAYTEACHERS is a web-based service available from the domain WWW.TEACHERSPAYTEACHERS.COM. This service provides teachers and publishers with an online marketplace to buy and sell educational materials directly from and to each other, which may consist of original digital or physical materials created by the seller ("Teaching Content"). The service provided by TEACHERSPAYTEACHERS is referenced herein as the "Service." TEACHERSPAYTEACHERS at no time owns or sells any product for or on behalf of teachers or publishers. Teachers who sell Teaching Content via the Service are referenced herein and in the Service as "Publishers who sell Teaching Content via the Service are referenced together, herein and in the Service, as "Sellers." Teachers who purchase Teaching Content via the Service are referenced herein and in the Service as "Teachers who purchase Teaching Content via the Service are referenced herein and in the Service as "Teachers Who purchase Teaching Content via the Service are referenced herein and in the Service as "Teachers Who purchase Teaching Content via the Service are referenced herein and in the Service as "Teachers Buyers."

This Terms of Service/User Agreement ("Agreement") governs your access to and use of the Service, whether in the capacity of a Teacher-Seller, Publisher-Seller, Teacher-Buyer, or visitor, including the finding, buying, posting, selling, and sharing of Teaching Content, and participating in online forums, feedback loops, bulletin boards, wikis, and chats, which features and activities shall also be considered part of the "Service." Portions of the TEACHERSPAYTEACHERS Service are publicly available to all visitors to the site. Other portions of the Service are available only to registered members who are Teacher-Sellers, Publisher-Sellers, and/or Teacher-Buyers (collectively, "Members"). By registering with TEACHERSPAYTEACHERS or by using the Service in any manner – including, but not limited to, by visiting the www.teacherspayteachers.com website – you acknowledge and agree to the terms stated in this Agreement. This Terms of Service applies to both visitors and Members.

# 2. The Service Is For Adults Only.

The Service is intended for adults only. You must be 18 years or older to use this site; users under 18 are not authorized to use the Service.

3. Fees, Services, Pricing, and Payments.

### A. Fees.

Membership Fees, Service Fees & Transaction Fees. Teacher-Sellers who wish to sell their Teaching Content through the Service must join TEACHERSPAYTEACHERS. Two types of memberships are available for Teacher-Sellers: (i) Basic Membership and (ii) Premium Membership. Basic Members who are Teacher-Sellers pay no annual membership fee. Premium Members who are Teacher-Sellers must pay an annual membership fee of \$59.95. Basic Members and Premium Members who are Teacher-Sellers both will be charged service fees on sales made through the Service. Premium Members who are Teacher-Sellers will also be charged a transaction fee on individual items if a Teacher-Buyer's purchase totals less than \$3.00. Both the service fee and transaction fees are set forth in greater detail in Section 3C below. Teacher-Sellers can upgrade membership from the Basic level to the Premium level at any time. New Teacher-Sellers are entitled to a 30-Day Money Back Guarantee which may be exercised by canceling membership through the Contact Us link. Teacher-Buyers who wish to purchase Teaching Content through the Service also must join TEACHERSPAYTEACHERS. Teacher-Buyers pay no membership fee to join TEACHERSPAYTEACHERS and there is no service fee for Teacher-Buyers who purchase materials from Sellers through the Service. One type of membership is available for Publishers, who can join and sell as Publisher-Sellers for no annual fee. Publisher-Sellers will be charged service fees on sales made through the Service, as set forth in greater detail in Section 3C below.

Shipping, Handling and Processing Charges. Teacher-Sellers and Publisher-Sellers may charge for shipping, handling, and processing of the physical materials that are sold via the Service in one of two ways: (1) by including the shipping, handling, and processing method and charges in the sale price of the item; or (2) by charging a flat rate for shipping, handling, and processing of all items sold, which will be reimbursed in full to you in your Monthly Payout (the amount to be paid to you each month pursuant to this Agreement).

## B. Pricing of Teaching Content.

Teacher-Sellers and Publisher-Sellers are solely responsible for setting the prices for the sale of their Teaching Content distributed through the Service, including for both electronic and physical materials, provided that such pricing (for items that are not offered free of charge) is not below the minimum price set by TEACHERSPAYTEACHERS. The minimum price is subject to change; the then-current minimum price will be disclosed each time a Seller uploads a product for sale. Sellers are obligated to sell their Teaching Content at the prices listed on the Service.

C. Agreement of Teacher-Seller and Publisher-Seller to Pay Fees and to Upload or Ship Teaching Content.

In consideration for the services provided by TEACHERSPAYTEACHERS, you (Teacher-Seller) agree to pay TEACHERSPAYTEACHERS a service fee ("Service Fee") for all Teaching Content you sell to Teacher-Buyers through the Service, in accordance with the following: (i) Basic Members will pay a Service Fee equal to 40% of the sale price of each item of digital Teaching Content sold plus 30 cents per item; (ii) Basic Members will pay a Service Fee equal to 40% of the sale price (excluding shipping) of each item of new physical Teaching Content sold plus 30 cents per item; (iii) Basic Members will pay a Service Fee equal to 15% of the sale price (excluding shipping) plus 99 cents per item, for each item of used physical Teaching Content sold; (iv) Premium Members will pay a Service Fee equal to 15% of the sale price of each item of digital Teaching Content sold; (v) Premium Members will pay a Service Fee equal to equal to 15% of the sale price (excluding shipping) of each item of new physical Teaching Content sold; (vi) Premium Members will pay a Service Fee equal to 10% of the sale price (excluding shipping) for each item of used physical Teaching Content sold; (vii) Publisher Members will pay a Service Fee equal to 50% of the sale price of each item of digital Teaching Content sold; (viii) Publisher Members will pay a Service Fee equal to 25% of the sale price (excluding shipping) of each item of physical Teaching Content sold.

In consideration for the services provided by TEACHERSPAYTEACHERS, Premium-Members also agree to pay a transaction fee ("Transaction Fee") of 15 cents per item (digital, physical or used), if a Teacher-Buyer's purchase totals less than \$3.00 (USD).

For each transaction, TEACHERSPAYTEACHERS will automatically deduct the Service Fee and in certain cases, the Transaction Fee, from the sale price collected from Teacher-Buyers through the Service, and then will distribute the remaining amounts to the Teacher-Seller and Publisher-Seller on a monthly basis as follows: (a) TEACHERSPAYTEACHERS will collect payment from Teacher-Buyers at the time Teaching Content is purchased through the Service, (b) TEACHERSPAYTEACHERS will notify you (the Teacher-Seller or Publisher-Seller) by email of the sale once payment has been verified and collected from the Teacher-Buyer, (c) in the case of physical Teaching Content, TEACHERSPAYTEACHERS will provide the Teacher-Seller or Publisher-Seller with the Teacher-Buyer's shipping address and any other information required for the Teacher-Seller or Publisher-Seller to fulfill the order, and (d) provided you are in compliance with these Terms, on a monthly basis, TEACHERSPAYTEACHERS will distribute the monies due to you (as a Teacher-Seller or Publisher-Seller) for the sale of your Teaching Content, in accordance with this Section 3C. If you are in breach of these Terms, for example due to violation of the conduct provisions in Section 6 hereto, TEACHERSPAYTEACHERS reserves the right, according to its sole discretion, to withhold any funds that would otherwise be due to you under these Terms, and either \_keep those funds permanently\_, or refund them to the Teacher-Buyers who purchased content from you. All monies due to Sellers pursuant to this Section 3C will be paid to such Sellers \_as close to \_21 days following the last day of the month in which an item of your Teaching Content is sold (e.g., within 21 days after January 31 for January sales). TEACHERSPAYTEACHERS reserves the right to delay payment. Monthly payments will be made through PayPal for all Teacher-Sellers and Publisher-Sellers; however users in the \_United States \_also have the option to receive payment via Dwolla. TEACHERSPAYTEACHERS reserves the right to add, remove or otherwise alter the payment processors used by the Service. If you (as a Teacher-Seller or Publisher-Seller) cannot acquire an account with an approved payment processor, we may consider an alternative form of payment

on a case-by-case basis. We make no representation regarding the services provided by our payment processors, and are not responsible for delays in payment caused by them. TEACHERSPAYTEACHERS will charge a fee for making each Monthly Payout that is equal to but not more than the cost to TEACHERSPAYTEACHERS from its respective payment processors for making the payout. This fee is subject to change at the discretion of the payment processors, and will be taken directly out of your Monthly Payout. You agree that upon notification of a sale of Teaching Content, you will promptly ship the relevant physical Teaching Content sold by you through the Service, in accordance with any representations made by you on the Service and/or in connection with such Teaching Content, including, for example, with respect to the pricing and shipping of such Teaching Content, and in any event in accordance with all applicable state and federal laws, rules, regulations, and/or industry standards. Teacher-Sellers and Publisher-Sellers are not authorized by the Service to ship to any address other than that which is provided to it by TEACHERSPAYTEACHERS.

### D. Additional Agreements and Obligations of Sellers.

By listing an item for sale, or uploading it to the Service, you (Teacher-Seller or Publisher-Seller) represent and warrant to prospective Teacher-Buyers that you have the right and ability to sell and to ship, and that the listing is accurate, current, and complete and is not misleading or otherwise deceptive. You further represent and warrant that the Teaching Content, and use of the same will not infringe any right – including, but not limited to the copyright or trademark right – of any third party.

If you are a Teacher-Seller or Publisher-Seller of digital Teaching Content, you agree to make at least one sample of such digital Teaching Content available to Teacher-Buyers at no charge at all times when you are offering digital Teaching Content for sale via the Service. When selling digital Teaching Content, you agree that the entire product being sold must be contained within the download offered, and that no part of such digital Teaching Content will be delivered separately or require an additional purchase, for example via a third-party website or other channel.

For any item of Digital Content you upload, you agree to provide your authorization, in the form of the statement below, to Buyers to print and make copies of free and purchased resources.

"The holder of this receipt is authorized by the owner or creator of the materials listed below, to print and/or make copies of these materials for personal use and/or classroom instruction."

Additionally, unless otherwise authorized, Sellers agree not to – and agree to cause their affiliates, agents, employees and contractors not to – use or disclose to any third party any order information, or other data or information regarding Teacher-Buyers or any other users of the Service, which is obtained through the Service or disclosed to Sellers by TEACHERSPAYTEACHERS in connection with a transaction made via the Service, for any purpose except as necessary to complete transactions made through the Service and otherwise fulfill their obligations under this Agreement (including, without limitation, for purposes of solicitation, advertising, direct marketing, harassment, invasion of privacy, or any other objectionable conduct).

If you (Teacher-Seller or Publisher-Seller) submit paid Teaching Content for inclusion in TEACHERSPAYTEACHERS' 10 Free Downloads newsletter, and such Teaching Content is selected for inclusion, you agree to pay TEACHERSPAYTEACHERS \$50, which will be deducted from your Monthly Payout. If your Monthly Payout is below \$1, you agree that TEACHERSPAYTEACHERS may charge this fee to your credit card or PayPal account.

# E. Member Sponsored Advertisements of Sellers.

Sellers may elect to purchase promotional space on the Service. The pricing and availability of such promotional space is made available via a module accessible through your Seller Dashboard. All purchases of promotional space are non-refundable. The cost of purchase will be deducted from your Monthly Payout. If your Monthly Payout is below \$1, you agree that TEACHERSPAYTEACHERS may charge your credit card or PayPal account for any promotional space purchased.

## F. Agreement of Teacher-Buyers to Pay for Purchases.

When you (Teacher-Buyer) purchase original digital Teaching Content you will have the ability to download the materials from your My Purchases page for as long as the materials are available through the Service. We may, in our sole discretion, make original digital Teaching Content you purchase available indefinitely, but your access to such materials through your My Purchases page may be disabled if the material is removed from the Service, for example, by the original seller as a result of the original seller's account being closed or the materials being removed in response to an intellectual property complaint or Digital Millennium Copyright Act notification. For this reason, we encourage you to download any original digital Teaching Content you may purchase, and to backup those materials accordingly. TEACHERSPAYTEACHERS cannot restore access to, or provide copies of, purchased materials that have been removed from our Service.

You agree not to share your purchases with your colleagues unless you have purchased additional licenses. You agree not to post your purchased or freely downloaded files on the Internet.

You agree to pay in full for all Teaching Content purchased through the Service, and agree that TEACHERSPAYTEACHERS may charge your credit card, PayPal or other account for any Teaching Content purchased, including any applicable shipping charges, and for any additional amounts (including any taxes and late fees, as applicable) as may be accrued to or in connection with your Member Account. If you chose to pay via School Purchase Order, you agree that TEACHERSPAYTEACHERS may charge your credit card or PayPal account for any Teaching Content purchased, including any applicable shipping charges, and for any additional amounts (including any taxes and late fees, as applicable) as may be accrued to or in connection with your Member Account if the invoice submitted in connection with any School Purchase Order has not been paid within 30 days of the date on which TEACHERSPAYTEACHERS invoiced your school.

YOU ARE RESPONSIBLE FOR THE TIMELY PAYMENT OF ALL SALES PRICES AND FEES, AND FOR PROVIDING TEACHERSPAYTEACHERS WITH VALID CREDIT CARD INFORMATION OR PAYPAL ACCOUNT DETAILS FOR PAYMENTS OF ALL SUCH FEES AND CHARGES.

You agree that delivery of the Teaching Content to you, whether electronically delivered or physically shipped and delivered to you, does not transfer to you any commercial or promotion use rights in the Teaching Content. You agree that your use of the Service (including your purchase of Teaching Content) constitutes your acceptance of and agreement to use the Service and such Teaching Content solely in accordance with this Agreement, and that any other use of the Service or Teaching Content may violate copyright and other laws of the United States, other countries, as well as applicable state laws, and you may be subject to liability for such unauthorized use. As a condition of use, you agree not to share your purchases with your colleagues unless you have purchased additional licenses.

### G. Service Credits.

When you (Teacher-Buyer) purchase original digital Teaching Content – and provide feedback in the form of a rating and comment – your account will receive 1 TPT Credit for each \$1 that you spend. TPT Credits have no cash value, but may be redeemed when purchasing Teaching Content through the Service at the rate of 5 cents per TPT Credit. When purchasing Teaching Content, you will be given the option of applying your TPT Credits to your purchase, thereby discounting your purchase price accordingly.

## H. Electronic Signatures and Contracts.

Your use of the Service includes the ability to enter into agreements and/or to make purchases electronically. YOU ACKNOWLEDGE THAT YOUR ELECTRONIC SUBMISSIONS CONSTITUTE YOUR AGREEMENT AND INTENT TO BE BOUND BY AND TO PAY FOR SUCH AGREEMENTS AND PURCHASES. YOUR AGREEMENT AND INTENT TO BE BOUND BY ELECTRONIC SUBMISSIONS APPLIES TO ALL RECORDS RELATING TO ALL TRANSACTIONS YOU ENTER INTO ON THIS SITE, INCLUDING NOTICES OF CANCELLATION, POLICIES, CONTRACTS, AND APPLICATIONS. In order to access and retain your electronic records, you may be required to have certain hardware and software, which are your sole responsibility.

### I. Limitations.

Your direct interactions (if any) with other visitors to or Members of the Service, including the purchase of, sale of, payment for, and delivery of goods or services, and any other terms, conditions, warranties, or representations associated with such dealings, are solely between you and that individual. Like with any web-based interaction, we suggest that you use caution and good judgment. You further understand and agree that TEACHERSPAYTEACHERS is not involved in any actual transactions made through the Service, and that it is not the agent or representative of any Teacher-Seller, Publisher-Seller, or Teacher-Buyer (or any visitor) for any purpose whatsoever and that it is not responsible for any loss or damage incurred as the result of

any such dealings or with respect to any other visitor's or Member's use or disclosure of your personally identifiable information. For details about our information collection practices, please see our Privacy Policy. IF THERE IS A DISPUTE BETWEEN YOU AND ANY THIRD PARTY (INCLUDING, WITHOUT LIMITATION, ANY MEMBER OR VISITOR OF THE SERVICE), TEACHERSPAYTEACHERS IS UNDER NO OBLIGATION TO BECOME INVOLVED, AND YOU HEREBY RELEASE TEACHERSPAYTEACHERS FROM ANY CLAIMS, DEMANDS, OR DAMAGES OF ANY KIND AND OF ANY NATURE ARISING OUT OF OR RELATING TO ANY SUCH DISPUTE. You agree that you are solely and exclusively responsible for any federal, state, or local taxes, including sales taxes, that might apply to any sales you make in connection with Service.

## J. Refund Policy

All physical and digital product sales are final, and no refunds are available.

TEACHERSPAYTEACHERS may in its sole discretion make certain exceptions to this policy on a case-by-case basis, for example if: (a) a digital file is defective; (b) a product description is materially deceptive or misleading; or (c) a physical item has not been shipped within two weeks of an order being placed. If such an exception is made, TEACHERSPAYTEACHERS may issue to the buyer a refund for such purchase in any manner it deems appropriate, including without limitation in the form of store credit.

As a buyer, it is your responsibility to determine that you have the appropriate hardware/software to make use of digital files, that the file format is appropriate for your needs, and that the content you are purchasing is legal and noninfringing. No refunds are available in these cases. Products removed from the Service due to a complaint of copyright/trademark infringement, or for any other reason, are not eligible for a refund.

If TEACHERSPAYTEACHERS elects to issue a refund to a buyer, the amount refunded will be deducted from the seller's next Monthly Payout, provided however that if the seller's next Monthly Payout is less than the refund amount(s), TEACHERSPAYTEACHERS may charge such refund amount(s) to the seller's credit card, PayPal account, or other payment processor account.

#### K. Transfer of Title

TEACHERSPAYTEACHERS does not transfer legal title or ownership of items from the Teacher-Sellers or Publisher-Sellers to the Teacher-Buyers, and nothing in this Agreement shall modify the applicable provisions of Uniform Commercial Code 2-401(2) and New York Uniform Commercial Code 2-401(2), which provide that, unless otherwise explicitly agreed between a seller and a buyer, legal title to a purchased item transfers to the buyer upon physical delivery of the item to the buyer from the seller. Accordingly, unless a Teacher-Buyer and Seller agree otherwise, legal ownership to any item of Teaching Content passes to the Teacher-Buyer upon the physical delivery of such item of Teaching Content from the Seller to the Teacher-Buyer.

# L. Referral Program

After registering for a new Seller account, you can use the "My Referrals" feature (available from a link located within the My Account portal) to receive a unique-to-you Promo Link. When new members register as Sellers with the Service using this link, your TEACHERSPAYTEACHERS account will receive 5% of that new member's sales for the first two years of their membership, added to your Monthly Payout, provided that the individual associated with the new Seller account has not previously opened any account through the Service. Please note that new Sellers must use this Promo Link directly when they sign up to qualify. TEACHERSPAYTEACHERS reserves the right to withhold payment – including Monthly Payout – or demand refunds from individual users who attempt to open multiple accounts using such Promo Links.

#### 4. License Grants.

## A. License Grants by Sellers to TEACHERSPAYTEACHERS.

When you (Teacher-Seller or Publisher-Seller) submit or upload content on or through the Service, you retain ownership of any copyright you claim to your submitted content. However, by making your content available through the Service you automatically grant TEACHERSPAYTEACHERS a royalty-free, perpetual, irrevocable (except as expressly set forth in this Agreement), non-exclusive, worldwide, sublicensable right to exercise any copyright, trademark rights publicity rights, and/or database rights (but no other rights) you have in the content, in any media now known or later developed, solely as reasonably necessary to make the Teaching Content available through the Service. IF YOU CHOOSE TO CANCEL YOUR MEMBERSHIP AND LEAVE THE SERVICE, AND/OR HAVE REMOVED YOUR TEACHING CONTENT FROM THE SERVICE, THIS LICENSE WILL BE DEEMED REVOKED AT THE TIME THAT YOU CANCEL YOUR MEMBERSHIP AND/OR REMOVE ALL SUCH TEACHING CONTENT, HOWEVER TEACHERSPAYTEACHERS' LICENSE TO MAKE TEACHING CONTENT YOU HAVE SOLD PRIOR TO CANCELLATION OF YOUR MEMBERSHIP AND/OR REMOVAL OF SUCH CONTENT AVAILABLE TO MEMBERS WHO HAVE PURCHASED SUCH MATERIAL PRIOR TO CANCELLATION OF YOUR MEMBERSHIP AND/OR REMOVAL OF SUCH CONTENT SHALL SURVIVE CANCELLATION OF YOUR MEMBERSHIP AND/OR REMOVAL OF SUCH CONTENT.

## B. Teacher-Seller and Publisher-Seller Representations and Warranties; Licenses to Other Users.

When you (Teacher-Seller or Publisher-Seller) submit or upload content (including without limitation Teaching Content) on or through the Service, you represent and warrant that (a) you have all the rights and/or licenses necessary to use, reproduce, publish, publicly display, publicly perform, distribute, and otherwise exploit such content in connection with the Service, including the right to grant to others all of the rights and licenses contemplated herein; (b) the content will not infringe or otherwise violate the copyright, trademark, or other intellectual property rights of any third party; and (c) you have the consent, release, and/or permission of each identifiable person depicted in your content to upload, transmit, publish, sublicense, and/or disseminate their

name and/or likeness through the Service. You (Teacher-Seller or Publisher-Seller) retain ownership of any rights – including, but not limited to, copyrights and trademark rights – you claim to your submitted content. As such you control the copyright licenses granted to a Teacher-Buyer and it is your responsibility to give notice to Teacher-Buyers of the terms under which you offer your Teaching Content to such Teacher-Buyers. TEACHERSPAYTEACHERS may, in its sole discretion, provide a means for Sellers to offer multiple licenses. Nothing in the Service or in these Terms limits the existing rights of Teacher-Buyers under the Copyright Act, including but not limited to rights under Sections 110(1) (classroom teaching), 110(2) (distance learning), or 107 (fair use) of the Copyright Act (17 U.S.C. 101 et seq.). You, Seller, may wish to consider applying one of the copyright licenses made available through Creative Commons to your Teaching Content. You can find out more about these licenses at the Creative Commons website located at www.creativecommons.org.).

## 5. Registration Obligations.

In consideration of your use of the Service, you represent that you are at least 18 years of age and are not a person barred from receiving these services under the laws of the United States or other applicable jurisdiction. You also agree to: (a) provide true, accurate, current, and complete information about yourself as prompted by the Service's registration form (the "Member Data") and (b) maintain and promptly update the Member Data to keep it true, accurate, current, and complete at all times. If you provide any information that is untrue, inaccurate, not current, or incomplete, or if TEACHERSPAYTEACHERS has reasonable grounds to suspect that such information is untrue, inaccurate, not current, or incomplete, without limiting any other remedies, TEACHERSPAYTEACHERS has the right to suspend or terminate your Member Account and refuse any and all current or future use of the Service (or any portion thereof). Please see our Privacy Policy for further information.

#### 6. Member and Visitor Conduct.

As a condition of using the Service, Members and visitors agree to all of the following:

- You must be a registered Member to buy or sell Teaching Content through the Service.
- You are required to select a member identification ("Username") and password. You are responsible for maintaining the confidentiality of your Username and password. You should not disclose your password to anyone.
- You are responsible for all activity that occurs under your Username.
- You are solely responsible for your conduct and any content, materials or information that you submit, post, and display on the Service, or that is submitted, posted, and/or displayed on the Service under your Username.
- You agree that you will not attempt to, nor encourage or assist any other person to, circumvent or modify any system, security technology, or other software that is part of the Service or used to administer the rules contained in this Agreement.

Further, while using the Service, Members and visitors agree not to:

- upload, post, email, transmit, or otherwise make available any content, material, or information to, on, or through the Service that is fraudulent, unlawful, harmful, threatening, abusive, harassing, tortious, defamatory, vulgar, obscene, libelous, pornographic, profane, sexually explicit or indecent, invasive of another's privacy, hateful, or racially, ethnically, or otherwise objectionable;
- upload, post, email, transmit, or otherwise make available to Members or visitors any unsolicited or unauthorized advertising, promotional materials, "junk mail," "spam," "chain letters," "pyramid schemes," "affiliate links," or any other form of solicitation;
- transmit any worms or viruses, spyware, malware, or any other harmful or destructive code;
